The Preproofer 760/960 automatically create double-sided proofs in eight-and Vierseitenformat. The system based on the proofers Epson Stylus Pro 7600 or 9600th. Similarly, paper widths of 61 cm (24") with the model 760 and 111 cm (44") with the model 960 will be printed.

Data management and control takes the DI-Plot software package.

If your form proof-producing economically?

The establishment of formal proofs is happening today with mostly manual fitting and gluing of two-sided printed Arch. Besides the considerable time involved remains the only single-sided printing is always a Arch page unused. Such hand crafting form proofs also hardly convince by their execution quality and difficult due to the double thickness of paper handling.

Two Epson Printer is on a stable platform of each other, associated with a top-down current Paper guide unit.

The pressure of the arc front (front) is from rolls with a capacity of 60 meters. The paper is automatically cut and where, moved by their own

Gravity, via the lower guide shaft printer.

Automatic, the arc of the second printer for the high register pressure back (back) is supplied.

The roller core with a diameter of 15 cm (6") prevent a rolling (curling) of the paper at the end of Paper roles effectively. The paper used "mediaware DIL Preproofer Duo "is specially produced for this core.
