## Contex FSS 8300 DSP Full Scale Scanner

The Contex FSS 8300 DSP Full Scale Monochrome scanner is a cost-efficient and high-performance solution for the quick scanning of large amounts of drafts.

This compact machine allows the capturing and administration of scanned documents. Sketches of dimensions up to 1016 mm (~40 inches) and standard Din A0 formats are automatically sampled at a rate of 914 mm (~36 inches). With the Contex FSS 8300 DSP you can digitalize documents on various media and convert them to CAD files, archive them or integrate them into highly developed GIS applications.
