Great tele-zoom SP AF 200-500mm FA / 5-6,3 Tu LD [IF]

This great tele-zoom of the Tu generation has desired everything what the heart of the successful nature or sports photographer. To do justice to the demands of the digital photograph, it was tuned to digital reflecting reflex cameras, however, can be used just in analogous cameras. The objective is equipped with a filter Effect Control, to the simplistic use of a Polfilters and a tripod adaptor. The chromatic aberrations which are a discernible problem with many telephoto lenses were minimised by the application of a LD element (LD = low dispersion) with low colour dispersion. Clear colours and high resolution with every focal length are the visible result of this optimisation.
