The solution works exclusively from the stick, not installed on the computer and acts invisible to existing security solutions. The mobile scanner is especially suitable for IT administrators, system-house technicians and help desk staff to investigate computer often with clients and colleagues for malware. The product can now be obtained from the Norman-partner.

For safety testing, the user selects the PC to test drive, folder, subfolder, or a single file with the mouse button. The brace of anti-virus software and spyware protection that detects and removes viruses, worms, Trojans, spyware and other types of malicious program code.

Reliable protection against unknown viruses

Like all anti-virus solutions by Norman Norman Security 2 Go works with the proactive SandBox technology. During the scan all suspicious programs are passed to the SandBox. This simulates a complete PC or a network, letting the unknown file execute their routines. They then undertake an assessment and classified the program as either a trustworthy or dangerous. Norman also offers thus an additional level of security beyond traditional signature-based virus scanning.

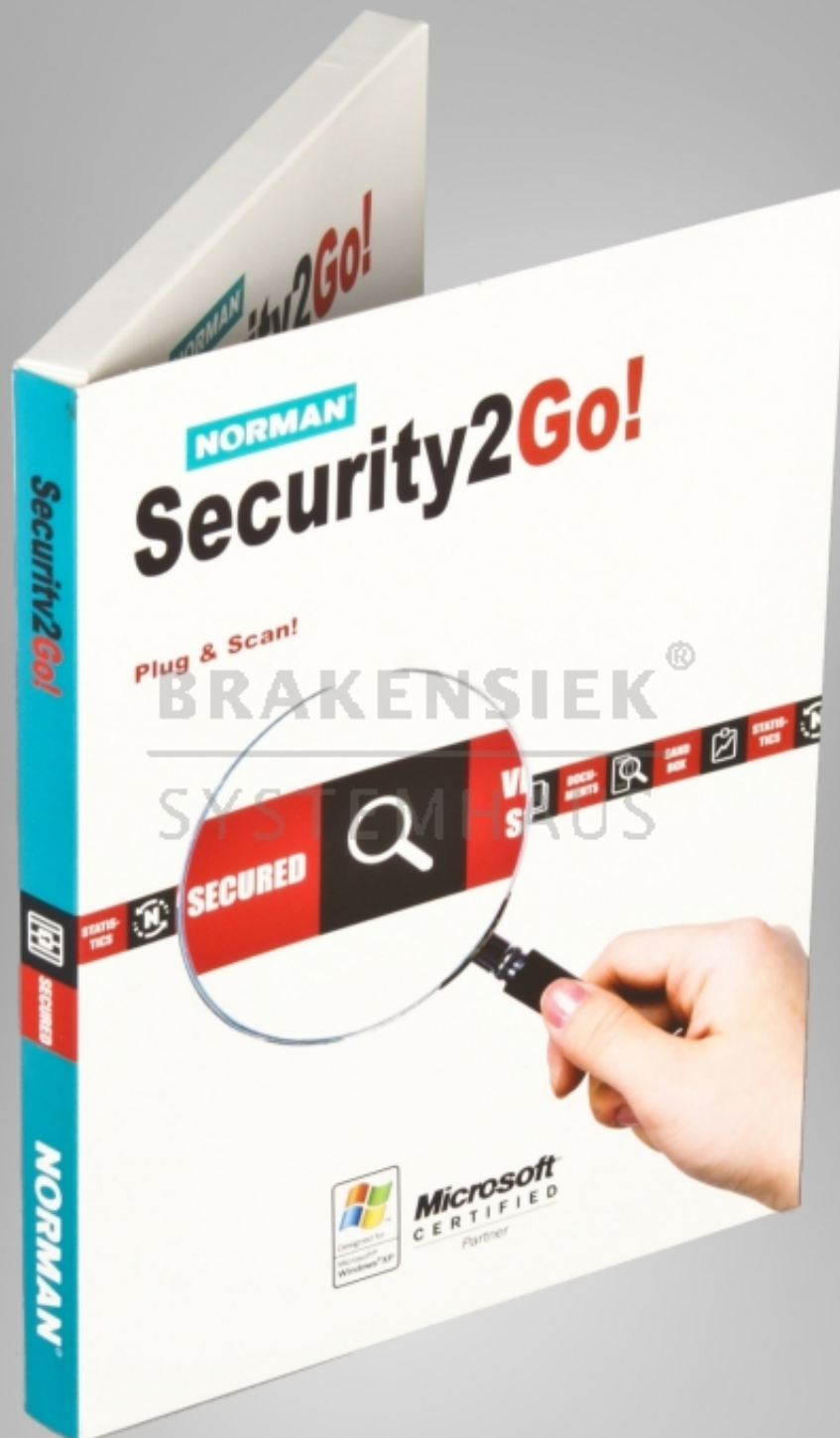
Price and Availability
